

OFFICIAL TERMS & CONDITIONS FOR THE "LOTTO 6/49 DEPOSIT BONUS" PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION

The "**Lotto 6/49 Deposit Bonus**" promotion ("Promotion") is available to residents of Nova Scotia, New Brunswick, and Newfoundland and Labrador from 00:00:00 Atlantic Time on May 13, 2025 to 23:59:59 AT on May 18, 2025. Participants must have a valid, active and funded alc.ca account.

To earn \$3 in Promo Cash, a player must deposit at least \$10 into their alc.ca account and spend a total amount of at least \$3 on Lotto 6/49 on alc.ca during the Promotion Period. The \$10 deposit and \$3 spend must both occur within the Promotion Period. Participants can earn a maximum of \$3 in Promo Cash during the Promotion Period.

Note: Residents of Prince Edward Island are not eligible for this promotion.

PROMOTION PERIOD

The promotion will take place between 00:00:00 Atlantic Time on May 13, 2025 and 23:59:59 AT on May 18, 2025 ("Promotion Period").

HOW TO PARTICIPATE

To participate in this Promotion:

1. A player must deposit at least \$10 into their alc.ca account and spend a total amount of at least \$3 on Lotto 6/49 at alc.ca during the Promotion Period. The \$10 deposit and \$3 spend must both occur within the Promotion Period.
2. The \$10 deposit criteria can only be met by a player manually adding funds to their alc.ca account during the Promotion Period. Online lottery subscriptions and lottery winnings automatically deposited into accounts will not be considered deposits for this Promotion.
3. Promo cash will not be accepted as a funding option.
4. Once all criteria are met the player will have their \$3 Promo Cash deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
5. To participate in the promotion, participants must be 19+; must be a resident of Nova Scotia, New Brunswick, or Newfoundland and Labrador; and must have an active and funded alc.ca online account.
6. The offer will run from 00:00:00 Atlantic Time on May 13, 2025 and 23:59:59 AT on May 18, 2025 ("Promotion Period").

PROMOTION RULES

1. Eligible participants can earn \$3 Promo Cash during the Promotion Period.
2. Once all criteria are met, the player will have their \$3 Promo Cash deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
3. The \$3 Promo Cash can only be used for alc.ca purchases. Not exchangeable for cash or cash equivalents.
4. The \$3 Promo Cash is non-transferable.
5. Limit of one (1) \$3 Promo Cash per alc.ca member/account.
6. Offer is only available to residents of New Brunswick, Nova Scotia, and Newfoundland and Labrador.

PROMOTION ELIGIBILITY

This offer is sponsored by ALC and is open to residents of New Brunswick, Newfoundland & Labrador, and Nova Scotia, who are nineteen (19) years of age or older, have an active and funded alc.ca account, and reside in Atlantic Canada at the time of entry. Residents of Prince Edward Island are not eligible for this promotion.

Note: Any individual who has falsified their registration information will be ineligible to receive their \$3 Promo Cash.

DELIVERY OF PRIZES

Once all criteria are met, the player will have their \$3 Promo Cash deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
