The "**Lotto 6/49 Deposit Bonus"** promotion ("Promotion") is available to residents of Nova Scotia, New Brunswick, and Newfoundland and Labrador from 00:00:00 Atlantic Time on May 13, 2025 to 23:59:59 AT on May 18, 2025. Participants must have a valid, active and funded alc.ca account.

To earn \$3 in Promo Cash, a player must deposit at least \$10 into their alc.ca account and spend a total amount of at least \$3 on Lotto 6/49 on alc.ca during the Promotion Period. The \$10 deposit and \$3 spend must both occur within the Promotion Period. Participants can earn a maximum of \$3 in Promo Cash during the Promotion Period.

Note: Residents of Prince Edward Island are not eligible for this promotion.

## **PROMOTION PERIOD**
