OFFICIAL CONTEST RULES AND TERMS & CONDITIONS FOR THE "IGAMES CONTEST MAY 2025" FROM THE ATLANTIC LOTTERY CORPORATION

The "IGAMES CONTEST MAY 2025" is sponsored by Atlantic Lottery Corporation ("ALC") and provides alc.ca players with a chance to win one (1) cash prize of \$10,000 each week (per the Weekly Contest Period). To earn entries, players must have a valid, active and funded alc.ca account, be nineteen (19) years or older and be a resident of Nova Scotia, New Brunswick, Prince Edward Island or Newfoundland and Labrador.

The Weekly Contest Periods are defined as and run as follows:

- 1. Thursday, May 1, 2025, at 00:00:00 Atlantic Time to Wednesday, May 7, 2025, at 23:59:59 Atlantic Time ("Week 1 Contest Period").
- 2. Thursday, May 8, 2025, at 00:00:00 Atlantic Time to Wednesday, May 14, 2025, at 23:59:59 Atlantic Time ("Week 2 Contest Period").
- 3. Thursday, May 15, 2025, at 00:00:00 Atlantic Time to Wednesday, May 21, 2025, at 23:59:59 Atlantic Time ("Week 3 Contest Period").
- 4. Thursday, May 22, 2025, at 00:00:00 Atlantic Time to Wednesday, May 28, 2025, at 23:59:59 Atlantic Time ("Week 4 Contest Period").

(each referred to as a "Weekly Contest Period" and collectively referred to as the "Weekly Contest Periods")

CONTEST PERIOD

The "**IGAMES CONTEST MAY 2025**" will take place from May 1, 2025, at 00:00:00 Atlantic Time to May 28, 2025, at 23:59:59 Atlantic Time ("Contest Period").

HOW TO PARTICIPATE

During each Weekly Contest Period, every cumulative \$5 wagered on Eligible Games on alc.ca and/or the Atlantic Lottery app, on each day of the weekly contest period will earn the player one (1) automatic entry into that Weekly Contest Period's draw for a chance to win one (1) cash prize of \$10,000 (refer to the weekly draw schedule below). Players can earn a maximum of one hundred (100) entries per day during the Weekly Contest Period. For example, if a player wagers \$5 on an Eligible Game on May 7, they would earn one (1) entry into Week 1 Contest Period draw for a chance to win one (1) cash prize of \$10,000.

Potential winners will have seven (7) days to provide their information once an ALC representative has contacted them via email. No purchase is necessary to enter this contest. See below for more details.

RANDOM DRAW AND ODDS

During each Weekly Contest Period, participants have a chance to win one (1) cash prize of \$10,000. The total prize value for the four (4) Weekly Prize Periods is \$40,000.

The odds of winning a prize will depend upon the total number of eligible entries received during the applicable Weekly Contest Period. All draws adhere to the draw procedures established for the draw by Atlantic Lottery.

A weekly random draw (each a "Weekly Draw") will be conducted for one (1) \$10,000 cash prize from all eligible entries received during the Weekly Contest Period. Please refer to the draw schedule below:

- 1. Week 1 Contest Period: May 14, or as soon as possible thereafter.
- 2. Week 2 Contest Period: May 21, or as soon as possible thereafter.

Government issued photo identification must be provided for proof of identification and age. ALC is not responsible for delayed or no delivery of any No Purchase Entry Request. Players can earn a maximum of one hundred (100) No Purchase Entries per day during the Contest Period. Players must have an active alc.ca member account created prior to sending the No Purchase Entry Request.

DELIVERY OF PRIZES

ALC will attempt to contact the potential winner within one (1) business day after the draw (or as soon as possible thereafter). If ALC is not able to contact the potential winner after seven (7) days after the initial attempt, ALC shall have the right to disqualify the potential winner, and the entry drawn immediately after the disqualified entry for the prize will be eligible to win the prize that otherwise would have been awarded for the previously selected entry.

Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of nineteen (19), they will be disqualified, and the next potential winner will be contacted. Winners will be notified by phone or email.
