

"PRO•LINE LAPSING PLAYER" PROMOTION

January 10, 2025 – February 28, 2025

The "PRO•LINE Lapsing Player" promotion is sponsored by ALC and provides select alc.ca players who wagered on PRO•LINE in Q3 (October, November, and December) of 2023 but have not made any wagers since October 1, 2024, an opportunity to redeem free-play tokens, as outlined in these terms and conditions.

There are three (3) player cohorts used to determine player eligibility and the corresponding offer. The offers are distributed via free-play tokens – automatically deposited into the players' alc.ca account – based on the following cohorts:

- 1. Cohort One: Active alc.ca players in the past three (3) months who have previously wagered \$10* or more on PRO•LINE but have not made a PRO•LINE wager since October 1, 2024. This player cohort qualifies for a \$5 free-play token.
- Cohort Two: Non-active alc.ca players in the past three (3) months who wagered \$10* or more on PRO•LINE in Q3 2023 (October, November, and December). This player cohort qualifies for \$20 in free-play tokens (2 x \$10 free-play tokens).
- 3. Cohort Three: Non-active alc.ca players in the past three (3) months who wagered less than \$10* on PRO•LINE in Q3 2023 (October, November, and December). This player qualifies for a \$5 free-play token.

* Please Note: All cohort eligibility is based on "cash" wagers – free-play tokens and promo cash values are not included as part of the total wager amount.

PROMOTION PERIOD

The free-play tokens will be issued on January 10, 2025 at 06:00:00 Atlantic Standard Time (AST) and expire on February 28, 2025 at 23:59:59 AST ("Promotion Period").

HOW TO PARTICIPATE

To participate in this promotion, a player must meet the following criteria:

- 1. Select valid alc.ca accounts opted in to receive promotional offers will receive an email advising them that a PRO•LINE free-play token(s) has been deposited into their alc.ca account.
- 2. Eligible players will have access to PRO•LINE free-play token(s) based on their corresponding cohort. No purchase necessary.
- 3. To participate in the promotion: participants must be 19+; must be a resident of New Brunswick, Nova Scotia, or Newfoundland and Labrador only and be eligible with a valid alc.ca account in compliance with the terms and conditions.
- 4. The offer will run from January 10, 2025, at 06:00:00 Atlantic Standard Time (AST) and closes on February 28, 2025, at 23:59:59 AST.

PROMOTION REWARDS

Eligible participants will receive PRO•LINE free-play token(s) based on their eligibility and corresponding cohort. Token(s) will be automatically added to accounts on January 10, 2025.

- 1. Participants must have wagered on PRO•LINE in Q3 of 2023 (October, November, and December) but not made any wagers since October 1, 2024.
- 2. Eligible participants must use their free-play token(s) by February 28, 2025, at 23:59:59 AST (token has no cash value otherwise).
- 3. Only one (1) token may be used on a single game. A single game includes the sum of all betting markets for that game. For example, you cannot use a token on the moneyline, and then use a second token on the same moneyline, the Spread, Total, H2H (head-to-head) or Winning Margins markets for the same game.
- 4. There is no cash option for this offer. Token(s) hold no cash value and cannot be used towards earning another token(s).
- 5. Token amount will be deducted from winnings.
- 6. Tokens are non-withdrawable.
- 7. This offer is non-transferable.

The PRO•LINE free play token(s) will be automatically added to eligible accounts. They can be found under "PRO•LINE Tokens" or "Free Bet Tokens" on the checkout page when placing a wager.
