CONTEST PERIOD

The "WINTER WIN-DERLAND CONTEST" will take place from January 10, 2025, at 00:00:00 AT to January 23, 2025, at 23:59:59 AT (Contest Period).

On January 29, 2025 (or as soon as possible thereafter) a random draw will be conducted for the contest from all eligible entries received during the contest period (January 10 at 00:00:00AM AT to January 23 at 23:59:59PM AT.)

If the potential winner has not contacted ALC within seven (7) days of being contacted, ALC shall have the right to disqualify the potential winner and draw an alternate winner for the same prize. ALC shall be fully and completely released and discharged from any liability or responsibility in this regard. Government issued photo identification must be provided for proof of identification and age.
